

### Individuals and Businesses

- · Can redirect Pennsylvania state tax dollars to provide scholarships.
- · Are eligible to receive up to a 90% PA tax credit.
- May be able to deduct a portion of the remaining 10% as a federal deduction.

#### **EVALUATE**

#### COMMIT

Review agreement with your tax professional, make donation, and receive tax credit document.

#### **CREDIT**

You receive a credit for up to 90% of your donation.
